The Federal Trade Commission Trade Regulation rule for "Cremation/Funeral Industry Practices" requires certain disclosures and prohibits misrepresentations. The following is a checklist we ask those we serve to read and sign to verify that the Cremation/Funeral disposition arrangements conference was conducted in compliance with the rule.

I made the arrangements for the disposition of the deceased named above and do hereby attest to the following: I was shown/given a general price list effective Oct. 2008, prior to discussing prices, services or merchandise. I was NOT told that embalming is required by law and WAS told that the law does not require embalming except in certain special areas.

I WAS NOT told that any law requires a casket for cremation. Direct cremation requires only composition materials, canvas or heavy cardboard box.

I WAS told that State law DOES NOT require the purchase of an outer container/burial container or any of the goods and services I selected except as set forth above.

I confirm that I have examined the above stated items and found them correct and according to the arrangements selected, and that prior to signing this statement I reviewed and approved a completed copy of this statement. I also confirm that I have been informed of my rights to select services as I desire.
